Agenda/Minutes:

Meet/Preparation of new officers: Everyone introduced themselves and Wanda went over the agenda for the meeting.

Rich and Wanda explained organizations that BC COLA collaborates/partners with for various events. We entered an interesting discussion of the role of BC COLA regarding "advocacy" versus "education" versus "legal support" of the various issues surrounding our lakes. As issues surface, serious consideration of "how to support" should be discussed.

Terms of new officers/Bylaws changed.

During the May membership meeting, the candidates will be introduced through a short bio that is sent to the membership.

The candidates will be voted on during the June meeting.

The candidates will officially take their new positions August 1, 2021.

The BC COLA bylaws state the process of election and taking office. Because of the extenuating circumstances and the nomination of the new officers to take over the entire leadership team, we are out of compliance with our bylaws. (Article V, Section 3). However, the bylaws do state that "The President, with approval of the Executive Committee shall appoint a replacement for any elected officer not able to complete a full term." Thus, the following decisions were made by President, Rich Cieslak, and the Executive Team.

- Remove any reference to "odd" or "even" years. (A, B, C, D)
- Addition of the following to Letter E: "If an officer leaves their position, the President and Executive Committee has the ability to appoint a person to that position".
- Addition to Letter F: "New Executive Committee members will be voted on during a BCCOLA meeting one month after they have been presented to membership."

These changes will need to be voted on by membership at the May meeting.

A copy of several new MN COLA policies was included in the meeting packet. These were not discussed at this meeting but need to be read through for a future meeting discussion and addition to BC COLA policies.

2021 Executive Committee and Membership meeting schedule/Comments:
